President Koch called the meeting to order. Present at roll call were Alderpersons Koch, Miller, and Newcomer. Also present were Director of Public Works Al Gerber, City Clerk Arianna Voegeli, Utilities Director Mike Kennison, Mayor Armstrong, City Administrator Phil Rath, Bridget Cooke of the Monroe Times, and Jesse Duff of Fehr Graham. G. UTILITIES SUPERVISOR

1. DISCUSS AND AUTHORIZE HIRING CONTRACTOR TO PAINT HYDRANTS

Utilities Director Mike Kennison explained that in 2016, the Board of Public Works authorized painting of 150 hydrants in the City. The contractor's schedule for 2017 was full, so they will honor the price from 2016 in 2018, which is \$110.00 per hydrant. This price includes an epoxy coating which is schedule to last 7-10 years or more. Kennison is looking for authorization for another 150 hydrants, which will complete about half of the hydrants in town. Discussion took place. Motion by Alder Newcomer to approve the hiring of contractor to paint

hydrants, seconded by Alder Miller. Upon voice vote, motion carried.

Motion by Alder Miller to approve the low quotes for 2018 base course materials and asphalt, provided they meet the specs as stated. seconded by Alder Newcomer. Upon voice vote, motion carried.

2. RECOMMEND TO COUNCIL HIRING ENGINEERING FIRM FOR 2018/2019 UTILITY DESIGN WORK

Director of Public Works Al Gerber explained that RFPs were put out for sewer and water main replacements to be completed in conjunction with street projects. Gerber recommends hiring Strand and Associates for \$59,500. Discussion took place. Director of Public Works clarified that this is for design only, and that it will still be required to go out for bid after design. Motion by Alder Newcomer to recommend to Council, seconded by Alder Miller. Upon voice vote, motion carried.
